MOOT COURT HONOR SOCIETY

The Moot Court Honor Society rewards and strengthens appellate and trial oral advocacy and writing skills. Members compete in the Grossman Trial Competition and MacKenzie Appellate Competition on campus, and in appellate and trial teams across the nation and in Europe. The Moot Court program at Syracuse is among the nation's strongest and enjoys a well-deserved reputation for excellence in appellate and trial advocacy.



Membership in the Moot Court Honor Society is determined by a two-part competition held in the spring semester. Applicants submit a brief, which accounts for 40% of their score, and present an oral argument to a panel of judges, which accounts for 60% of their score. Nearly 200 first-year students compete for 32 spots, with new members notified at the end of the spring semester. Members are

required to enroll in Evidence and Appellate Advocacy courses in the fall semester and Trial Practice in the spring semester of their second year.

Moot Court Honor Society sponsors various other teams, each with their own membership requirements, including:

Honorary Societies



Overview

Syracuse University Honorary Societies are merit based societies. Inclusion in these societies is by invitation only and is generally dependent upon a student’s academic performance.

JUSTINIAN HONOR SOCIETY

Membership into the Justinian Honor Society is extended to the top 20% of the third year class (senior members) and to the top 10% of the second year class (junior members). The president and secretary are appointed to their positions according to their class rank of number one and number two at the end of the fall semester of their second year.

ORDER OF BARRISTERS

The Order of Barristers is a national honorary organization whose purpose is the encouragement of oral advocacy and brief writing skills through effective law school oral advocacy programs. The Order of Barristers originated in 1965 at The University of Texas at Austin School of Law. The purpose was to honor graduating seniors who had demonstrated outstanding ability in the preparation and presentation of moot appellate argument. The Order was officially established as a national organization in 1970.

During the spring of 1971, a number of schools submitted applications for membership and the current roll boasts over 100 law school chapters throughout the nation. Schools having chapters in the Order include those nationally recognized for outstanding moot court programs and for successful participation in regional, national, and international interscholastic moot court competitions.

ORDER OF THE COIF

The Order of the Coif is a national honorary scholastic society the purpose of which is to encourage excellence in legal education by fostering a spirit of careful study, recognizing those who as law students attained a high grade of scholarship, and honoring those who as lawyers, judges, and teachers attained high distinction for their scholarly or professional accomplishments.

Membership into the Order is extended to those in the graduating class who are in the top 10% of their class at the end of the Spring semester.

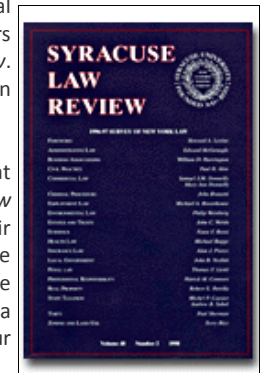

SYRACUSE LAW REVIEW

The *Syracuse Law Review* is a legal publication that provides an intense legal research and writing program for student editors and a national forum for scholars who contribute to it. Second-year editorial staff members write notes for possible publication in the *Law Review* and assist in editorial activities. The third-year editorial board members supervise all aspects of publication of the *Law Review*. Third-year members receive 2-3 academic credits based on their participation in *Law Review*.

Law Review membership is a distinguished honor at Syracuse. Full-time students are invited to join the *Law Review* based on their first-year grades or their achievement in an open writing competition held at the conclusion of the first year. Part-time students are eligible for membership based solely on their performance in a writing competition after the completion of twenty-four hours of academic credit.

The *Syracuse Journal of International Law and Commerce* is one of the oldest student-edited international law reviews in the United States. Its mission is to produce two journals of exceptional quality each year and to stimulate interest among students in the areas of international law and commerce.

The *Syracuse Journal of International Law and Commerce* extends an invitation to join to the top 15% of the first-year class. Additionally, other first-year students may submit a writing sample for consideration. The authors of the top scoring papers are issued an invitation to join the *Journal* staff. Those who accept the invitation become Associate Editors during their second year of law school.

Associate Editors are required to enroll in the entry-level International Law class in the fall semester of their second year and are required to write a thirty-page note of publishable quality on an international law topic of their choice. All Associate Editors will receive one law school credit for their participation.

JOST offers membership invitations to the top 20% of the first-year class. Students may also take part in a writing competition. Students need not be focusing on technology law, but should have some interest in the area and a desire to gain valuable writing and editing skills.

Associate Editors are required to write either a twenty-five page research paper involving law and technology, or a series of book reviews of comparable length. Associate Editors receive one credit for their participation.

The Special Recognition Awards will be given out in connection with the end of year graduation and convocation exercise, and will be noted in the graduation materials. In addition, students will be permitted to wear a special signifier at graduation, as provided by the College. Pro Bono Program

Overview

Lawyers are professionals with an obligation to serve the legal profession and their community. This obligation begins with enrollment in law school. In order to meet this obligation and to implement a process for instilling a sense of service in our students, we encourage every student at the Syracuse University College of Law to participate in Pro Bono and Service Activities.

In an effort to centralize the different opportunities for students, the Office of Student Life created the Pro Bono Program. Through this program, students can find information on different service events—from one time service opportunities to continued projects that enable a student to work on legal issues from start to finish.



Because the College of Law is proud of our students' commitment to pro bono and community service work, we have created a special recognition program. In order for a student to receive special recognition at graduation, a student must be in good academic standing and have completed at least *50 hours of volunteer work. 80% of the hours completed must be law related pro bono work. 20% of the hours can be traditional community service (such as volunteering at homeless shelters, soup kitchens, tutoring, home building projects, etc.). There are two categories of Pro Bono and Community Service Recognition Awards.

BLACK LAW STUDENTS ASSOCIATION

As an organization, the Black Law Students Association (BLSA) is committed to providing support and encouragement in order to help facilitate a smooth adjustment process.
